7. THIS DOCUMENT SHALL CONSTITUTE THE ENTIRE CONTRACTUAL AGREEMENT BETWEEN *Stan Dixon Entertainment* and the above named and the same as signed below.

8. The parties named and those that signed agree as follows:

*Stan Dixon Entertainment* shall be present to play music from disc or other recording medium in disc jockey style on the date and time and at the location that is listed above. It is further agreed that Stan Dixon Entertainment shall have access to the premises of the event AT LEAST TWO (2) HOURS PRIOR to the scheduled starting time of the event and AT LEAST ONE (1) HOUR AFTER the ending time of the event. It is also agreed that *Stan Dixon Entertainment* shall be allowed free, unlimited and exclusive access to at least two (2) 15 amp 120 volt electrical circuits for the duration of the event, including set-up and take-down time. Music and other typical disc jockey duties (including dinner music) will be provided for the duration of the event, or until an agreed upon ending time. However, consideration of the premises may also determine the ending time of the event.

9. ALL MUSIC REQUESTS AND ANY OTHER PAPERS ARE NOT CONSIDERED A PART OF THIS AGREEMENT. It is also agreed upon that this page and its contents are the only binding agreement between the client and company.

10. In consideration for the above mentioned services, the signees (clients) agree to pay the sum of \$ \_\_\_\_\_, which is payable in full upon arrival of the entertainer at the location of the event, minus the already paid non-refundable amount (retainer) required to reserve the event date. No date will be held unless reservation retainer is paid. Payment to be made in cash, money order, or certified check to **Stan Dixon**.
